Rochester's Leash Law

All dogs in the City of Rochester are required to be restrained by a leash while off their owner's premises, whether the dogs are or are not tagged or licensed. Dogs are permitted to be unleashed while off their owner's premises when on the premises of another person with that person's consent. No person who owns, keeps, harbors or has the care, custody or control of any dog in the City of Rochester shall permit a dog to be at large or be unleashed except with permission by the law. Whenever a dog is outside the owner's house, on the owner's premises or on the premises of another with that person's consent, the dog must be under the control of the owner, on a leash or in a fenced area so the dog cannot leave the premises. A leash shall not extend beyond the premises onto other premises without that property owner's consent or onto public property, or the dog will be considered unleashed.

One of the ongoing issues that we in the neighborhood, and in the neighborhood association have been dealing with for a long time is the issue of the proposed new parking lot on the existing green space along Lattimore and the medical building. It will require a change of parking hours along the south side of Lattimore Road and parts of Norfolk Street and Eastmoreland Road to allow extended parking during the day. Rochester's Leash Law

Leash Law Violations

- Initial Penalty - First Offense - \$100
- Upon Default - \$200
- Second Offense - \$250
- Upon Default - \$500
- Third and Subsequent Offense - \$500
- Upon Default - \$1,000

Unlicensed Dog Law

All dogs in the City of Rochester are required to be licensed. The penalties for unlicensed dogs are:

- Initial Penalty - First Offense - \$25
- Upon Default - \$50
- Second Offense - \$50
- Upon Default - \$100
- Third and Subsequent Offense - \$100
- Upon Default - \$200

Howling or Barking Dogs

No person shall keep or harbor a dog, which howls or barks continually and is audible beyond the property line of the premises on which the dog is located:

1. For more than five (5) minutes between the hours of 10:00 p.m. and 8:00 a.m.; or
2. For more than 15 minutes between the hours of 8:00 a.m. and 10:00 p.m.; or
3. For a shorter duration than cited above, but on more than five (5) occasions within a ten-day period if attested to by complaints from two or more separate properties.

It shall be a defense to such violation if the owner of the dog proves by a preponderance of the evidence that the only reason the dog was howling or barking was that the dog was being provoked by a person or was otherwise being incited, or was acting as a guide dog, hearing dog, service dog or police work dog.

Dog Complaint Division

The Dog Complaint Division is established in the City of Rochester Parking Violations Bureau and is authorized to hear and determine complaints of violations relating to the licensing, identification and control of dogs. Cleanup after Dogs

As a reminder, it is common courtesy and respectful of your neighbors to clean up after your dog (s). Newspaper bags, plastic food bags and baggies come in very handy.

Crime Information Bulletin

The Rochester Police Department would like to make you aware of the burglary crime pattern in the neighborhoods around Mt Hope Av. and Menlo Place.

During the past few weeks, there have been several burglaries in this general area, many of which the suspect gained entry through an unlocked point. The Rochester Police Dept. currently has no suspect description or other information to help identify the person(s) responsible for these crimes.

We need your help to stop this crime pattern. Please be observant of activity in your neighborhood. Report anything unusual to 911 immediately. Record license plate numbers of suspicious vehicles and / or detailed descriptions of suspicious persons.

If you have information regarding any of these crimes, please call the Highland Section ASAP at 428-7262 or call 911.

The Highland Section Crime Prevention Unit would like to remind all residents of this neighborhood to follow these basic tips to deter crime:

- 1. Report to 911 immediately all suspicious activity such as persons loitering, going door to door, or the sound of glass breaking.**
- 2. Report any attempt to break into your house or garage, such as cuts on your screens near the locks.**
- 3. Keep your doors, windows and garages locked when not at home.**
- 4. Notify a neighbor when you are going to be away.**
- 5. Discontinue mail and newspaper delivery when going on vacation.**
- 6. Trim shrubs to deny burglars a hiding place, especially shrubs around first floor and basement windows.**
- 7. Lock up ladders and trash toters where they cannot be used by a burglar.**

Be a good neighbor...watch your neighbors' property.
